"REDUCE THE MEDS- REDUCE THE RISK" DEA TAKE BACK EVENT IN SOUTH GLENS FALLS

South Glens Falls, NY – The Community Coalition for Family Wellness (CCFW) and the Saratoga County Sheriff's Department are announcing two DEA Medication Take Back Day locations in the Town of Moreau. The

Moreau Community Center and the Moreau Emergency Medical Squad will be open from 10-2 on Saturday, April

29th to accept any unused, expired or unwanted prescription medications.

The Community Coalition for Family Wellness (CCFW) is addressing prescription drug and heroin abuse by preventing easy access to potentially dangerous medications in the home. Surveys of South Glens Falls students show that a quarter of all students 12-18 find prescription medications 'Easy' to obtain. Similarly, surveys of young adults, ages 18-25, found that two thirds report prescription medications 'Very Easy' or 'Somewhat Easy' to find. According to the National Institute of Drug Abuse, 53% of all medications misused by teens comes from their own home or the home of a friend or relative. CCFW also provides medication disposal bags at locations throughout Moreau and the village of South Glens Falls, prescription drug drop boxes and take back locations through our Reduce the Meds-Reduce the Risk program. In 2016, the DEA Drug Take Back Day event collected 1,400 pounds in Saratoga County

Partners with the Community Coalition for Family Wellness (CCFW) that support the Prescription Drug Take Back Day effort inluce: The Saratoga County Sheriff's Office, Moreau EMS, the Moreau Community Center, the US Drug Enforcement Administration, Recovery Adovacy in Saratoga, the Saratoga-Wilton Eks Lodge, and the Prevention Council of Saratoga County. The Coalition's heroin use and prescription drug missuse efforts are funded through the Partnership For Success Grant from the New York State Office of Substance Abuse Services (OASAS) and the Subtance Abuse and Menatl Health Services Administration (SAMSHA).

Unfortunatly no needles, radiological, or liquid medications can be accepted at these events. The Moreau EMS station is located at 1583 Route 9, Moreau New York and the Moreau Community Center is located 144 Main St. South Glens Falls New York. Each site will be open from 10 am until 2 pm on Saturday April 29th for any individual to drop off unused, expired or unwanted medications.

South Glens Falls, NY – The Community Coalition for Family Wellness (CCFW) announces a community forum on Addiction and the Opioid Epidemic in northern Saratoga County. Parents, students, community leaders and residents are encouraged to attend and join in on the discussion at a free community forum and panel discussion on Wednesday May 10 from 6-8 p.m. at the South Glens Falls High School Auditorium to discuss the effects of the opioid epidemic locally and tangible ways we all can address the needed change.

The progam will be hosted by Marcie Fraser and feature speakers Assembly Member Carrie Woerner, Saratoga County Sheriff Michael Zurlo, Prevention Concil Executive Director Janine Stuchin, Saratoga County Mental Health Director Michael Prezioso, and Albany DEA Agent in Charge David Zan. Information on Nar-anon, Narcan trainings, medication disposal and education tool kits will also be available.
